

## RURAL ELECTRIFICATION EXPANDS OPPORTUNITIES IN KWALE COUNTY

Communities in Kwale County witnessed a significant milestone in electricity access following the commissioning and launch of rural electrification projects in Matuga and Msambweni constituencies.

Energy and Petroleum Cabinet Secretary Opiyo Wandayi presided over the events alongside Kwale Governor Fatuma Achani and other national and local leaders. REREC was represented by Chief Executive Officer Rose Mkalama.

The Fuzo–Mkokoni electrification project in Matuga Constituency will connect 202 households, while the Madongoni–Majikuko project in Msambweni Constituency will bring electricity to an additional 164 beneficiaries once completed.

These initiatives form part of the Government’s broader strategy to expand reliable and affordable electricity access across the country. For many households and small businesses, electricity access will unlock opportunities for enterprise development, improved education outcomes, and enhanced security within rural communities.

Through such projects, REREC continues to support inclusive development while accelerating the national goal of universal electricity access.

## NANDI ELECTRIFICATION PROJECT CONNECTS RURAL HOMES

Residents of Kibongwa Village in Tinderet Constituency, Nandi County are now benefiting from reliable electricity following the commissioning of the Kibongwa Rural Electrification Project.

Energy Principal Secretary Alex Wachira presided over the commissioning event, accompanied by Diaspora Affairs Principal Secretary Roseline Kathure Njogu and ICT and Digital Economy Principal Secretary John Tanui.

The project has connected approximately 200 households alongside key public institutions including churches, schools, and Kibongwa Dispensary, improving access to essential services for the community.

During the event, the Energy Principal Secretary announced

that KSh 1.35 billion has been allocated to electrification projects across Nandi County, reflecting the government’s commitment to expanding energy access and supporting sustainable development in rural areas.

The project has connected 278 homes and several public facilities including churches and boreholes to reliable electricity. The commissioning was marked by a symbolic switch-on ceremony at the salon business owned by local entrepreneur Everline Silia, demonstrating the direct economic opportunities electricity brings to rural communities.

The government has invested more than KSh 900 million in electrification projects across Siaya County targeting

These projects represent a major step toward expanding energy access while supporting the government's economic empowerment agenda.
