21 projects were commissioned in the week ending 15/10/2021, in various parts of the country.

The total number of commissioned projects currently stands at 1420 as compared to 1399 projects that had been commissioned by 08/10/2021. The number of projects in progress is 898 out of the cumulative 2318 projects under implementation in the in 2020/2021 FY. 143 projects are awaiting either joint inspection, shut down or commissioning.
